DVD LICENSE AGREEMENT

This License Agreement is made between Iowa State University of Science and Technology on behalf of its Department of Food Science and Human Nutrition Dietetics Academy “Current Issues in Nutrition” Rental Library (“ISU”) and the person named below (“Licensee”) who desires to rent a DVD of a past program presented during a prior ISU “Current Issues in Nutrition” Program (“DVD Rental”).

In consideration of the mutual covenants and promises in this Agreement, ISU and Licensee agree as follows:

1. ISU grants, and Licensee accepts, a non-transferable, non-exclusive license (“License”) to view the above-titled program previously presented at an ISU “Current Issues in Nutrition” Program. This License is provided to the individual Licensee for educational non-commercial purposes only. Use of the DVD Rental for group educational purposes is strictly prohibited.

2. Licensee may not tamper with, duplicate or resell the DVD Rental.

3. The rental fee identified above must be paid to ISU prior to delivery of the DVD Rental. Payment shall be made by credit card only – no cash, check or money orders will be accepted.

4. The License for use of the DVD Rental is for a period of three weeks from the date it is mailed to Licensee by ISU. The DVD Rental must have a return postmark within three weeks of that original postmarked mailing date.

5. Late/Damage Fee. Licensee agrees that if the DVD Rental is not returned by the due date, is returned damaged, or is returned otherwise unuseable by ISU, Licensee will pay ISU \$600.00. This late fee/damage fee will be charged directly to the Licensee's credit card provided at the time the DVD Rental is requested.

6. It is understood between the parties that the views expressed by the speakers presented during the "Current Issues in Nutrition" programs are the views of the speakers and are not intended to be endorsed or supported by Iowa State University, the Department of Food Science and Human Nutrition, or the Dietetics Academy.

7. Licensee agrees that the DVD Rental provided by ISU remains the property of ISU. Licensee shall have no right, title or interest in any ownership of the DVD Rental. Upon expiration of the term of this License, it is the obligation of Licensee to return or destroy the DVD Rental.

8. INDEMNIFICATION. Licensee agrees to INDEMNIFY AND HOLD HARMLESS the State of Iowa, the Board of Regents of the State of Iowa, Iowa State University of Science of Technology, the Department of Food Science and Human Nutrition, the Dietetics Academy, and any of its officers, servants, speakers, agents and employees for any liability, claim and/or cause of action arising out of the Licensee's use of this DVD Rental or any other person's use or access to this DVD Rental during the time period it is in the possession of Licensee.

9. This Agreement shall be governed by the laws of the State of Iowa.
